Dist. for running of B.Sc. Nursing 4 years Course has been registered with the Dr. NTR University of Health Sciences, Vijayawada and continuation of provisional affiliation is granted to run **8th batch** of B.Sc. Nursing 4 years course and for admitting the students with an intake of **50 (fifty)** students for the academic year 2011-12, subject to fulfillment of the deficiencies noted by Indian Nursing Council, New Delhi, & Approval of INC., New Delhi and subject to fulfill the conditions laid down in Annexure.
